# **CELOTEX CW4000**

# **Description**

**CELOTEX CW4000** is a rigid thermal insulation board made of polyisocyanurate (PIR) foam. The boards are provided on both sides with a low emissivity aluminium composite foil facing. **CELOTEX CW4000** is mainly used as thermal insulation in partial fill cavity wall application.
